## 1º CALL FOR SELECTION OF *AD HOC* REVIEWERS

### 1 ABOUT THE JOURNAL

1.1 The Revista de Direito Contemporâneo UNIDEP (RDC-U) (Journal of Contemporary Law UNIDEP) is a biannual electronic scientific journal maintained by the Centro Universitário de Pato Branco (UNIDEP), with the aim of disseminating and encouraging scientific production, promoting academic debate from an interdisciplinary perspective. The journal aims to promote, in a primordial way, the discussions about the interrelationships between Law, technology and technological innovations, added to the others discussions in vogue in the legal scenario in our times.

1.2 The RDC-U is intended for the publication of unpublished scientific papers, in the forms of scientific articles, contemplating different approaches and having as a requirement the methodological standards recognized in the scientific production.

1.3 The journal's editorial line is Contemporary Law, which, in turn, brings together two important lines of research:

a) Law and Technological Innovations: this line of research proposes the promotion of academic debate, under interdisciplinary perspectives, regarding the interrelationships between Law, technology and technological innovations, identifying problems in this connection and, when possible, suggesting ways and resolutions.

b) Law Updates: this line of research aims at the promotion of academic debate, under interdisciplinary perspectives, regarding diverse situations in the national and international legal scenario, such as contemporary theoretical and practical discussions and recent doctrinal and jurisprudential positions.

### 2 ABOUT THE CALL FOR *AD HOC* REVIEWERS

2.1 Through the publication of this notice, the RDC-U invites researchers who meet the requirements below for selection and composition of new members of the Board of Reviewers. The first edition of the journal is expected to be released in mid-2022, although the composition of the Board of Reviewers is also intended for later editions, according to the editorial need and availability of the reviewer.

2.1 Requirements for registration in the selection process are:

- a) Have updated Lattes curriculum (if Brazilian). If foreign, own and indicate updated ORCID;
- b) Hold a master's or doctor's degree, or be linked to a master's or doctoral program in law or related areas;
- c) Desirable, but not mandatory, that the candidate has basic knowledge about the areas covered by the journal's editorial line;
- d) Certify availability for at least two opinions per semester, following the deadlines, rules and procedures agreed between the journal and the selected reviewer.

2.2 Candidates must register in the selection by sending email to the magazine [right@unidep.edu.br](mailto:right@unidep.edu.br), indicating "CALL OF REVIEWERS" in the field "Subject", and informing:

- a) Full name;
- b) Academic degree;
- c) Name of Higher Education Institution in which you have completed or are studying a Master's or Doctorate;
- d) Year of completion of the Master's or Doctorate degree or, if the candidate is a Master's or PhD student, the year foreseen for completion;
- e) Current institutional links, indicating the Higher Education Institution and the position held by the applicant respectively;
- f) E-mail address;
- g) Phone contact;
- h) Languages in which you can act as a referee (Portuguese, English or Spanish).

### 3 GENERAL PROVISIONS

3.1 The rights of the selected reviewers are:

- a) Receive certificate of completion of evaluation after completion of its work, provided that the terms stipulated in this Notice and those agreed between the journal and the selected reviewer are observed; and
- b) Request, at any time, a statement that makes up the Board of Reviewers for purposes of verification in Higher Education Institutions or research funding agencies.

3.2 The evaluation papers will not be remunerated and, because it is an electronic publication, the journal does not forward copies of the edition in which the reviewer participated.
